It gives me great pleasure to recommend the installation of the Beta Upsilon Colony of Delta Sigma Pi at Baker University.



***WELCOME TO BAKER UNIVERSITY***



Since its beginning, Baker University has prided itself on "firsts." Chartered on February 12, 1858, Baker is Kansas' oldest four-year university. Its namesake, Osmon Cleander Baker, presided over the first conference of the Methodist Episcopal Church. Indeed Baker's first graduating class had a twenty-five percent female population, which was unheard of at that time.



Located in Baldwin City (forty miles southwest of Kansas City and forty-five miles southeast of Topeka), the antiquity of the university is a daily reminder of Baker's long established tradition of excellence. Parmenter Hall, the oldest building on campus, received a 100 dollar donation for its construction from Abraham Lincoln. The original structure changed in 1938, and then again last year. Today, Parmenter houses the Art Department, the Admissions Office, the Alumni Office, and the office of the Minister to the University, and such historic rooms as the Lincoln Parlor, Holt Art Gallery, and the Darby-Hope Theatre. Although Parmenter has changed many times, its original bell tower has been preserved, and today stands as the symbol of the university.





The Old Ten O'Clock Bell dates back to February 22, 1860. This bell rang for many years to awaken students for their daily chapel at 8 A.M., to announce classes, and to sound the retirement hour--thus, giving it its name. The bell tolled when word came of Lincoln's death. Seemingly insignificant, the Old Ten O'Clock bell stands as a mute witness of many years of college life and enthusiasm.

Case Hall, erected in 1898, is on the National Historic Register. The Education, Philosophy, and Religion Departments all reside in Case.

Mabee Memorial Hall has much to be memorable about. It was originally built as a gymnasium, called Taylor Hall, in 1908. President Howard Taft delivered the pronouncement for world peace here on September 24, 1911. Taylor Hall burned and was restored. The restored building was named Memorial Hall honoring those who served in World War II. It was again renovated in 1972 and was given its current name, Mabee Memorial Hall. It is the location of physical education and football programs, including a weight room and swimming pool. And, most recently, it has also become the home of our own Department of Business and Economics.

Baker University built a new gym in 1985 named George F. Collins, Jr. Sports and Convention Center. It is the home of the Baker Hall of Fame and the Markham Conference Room. The gym contains two practice basketball courts, the varsity court, four racquetball courts, a jogging track, athletic support facilities, and offices for the athletic staff.

Liston Stadium and Richard Outdoor Sports Complex provide practice and varsity fields for football, track, baseball, softball, and soccer. They are located a few blocks east of the campus.



To those of us who love books, the evolution of the Baker Library is an interesting tale. The library has been seen in several places. After being shuffled around in Old Science Hall (now Parmentor Hall) for over forty years, the library found permanence in 1904. Andrew Carnegie gave a generous donation of \$12,000 providing that the college would raise \$36,000 towards a library building. The corner stone of the new building, named Collins Library, was laid September 13, 1904, and completed in August, 1907. There were 13,000 books at this time in the collection. In 1932, a study was done on the quality of the books by the Carnegie Corporation of New York. The result of this examination was a gift of \$6,000 to be

used for the purchase of books. Several great gifts were presented to the library but the greatest gift of all was the collection of rare Bibles willed by Bishop William A. Quayle, which is still visited by many today.

Pulliam Center, built in 1872, was known as "The Old Stone Church," and is also on the National Historical Register. It was renovated in 1978, and now serves as the headquarters for the Communication program, including the radio and television stations, The Baker Orange and Pieces, the campus newspaper and magazine. The Missouri Wesleyan Room, and the Eugene Pulliam Room are found here too.

Rice Auditorium was built in 1955, and renovated in 1983. It is the home of the theatre program and serves as the center for fine arts events.



Mulvane Science Hall was built in 1925. It has been renovated periodically. Biology, Chemistry, Computer Science, Mathematics, and Physics are located in Mulvane. In 1988 the exterior of Mulvane was renovated and landscaped.

In 1966, Owens Musical Arts Building was built to house the student music



programs. It houses McKibbin Recital Hall, the Audio Visual Room, the Band Room, the Piano Laboratory, and faculty offices.

Harter Union was added to the campus in 1959.

It contains the Truman Allen Dining Hall, student senate, student services offices, and a student lounge. It holds a bookstore and a snack bar which have both undergone renovation in the last year.

Ivan L. Boyd Woods is a 35-acre area two miles north of Baldwin. It is used by the biology classes and independent studies to investigate ecological

phenomena common to woodland area. It is valuable for studying woodland species of plants and animals.

Baker Wetlands Research and Natural Area is a 573-acre area 11 miles northwest of Baldwin in the Wakarusa River floodplain. It contains 45-acres of wetland prairie and is the habitat of the threatened Northern Crayfish Frog. Baker acquired the land from the federal government in 1968. It is identified as the National Natural Landmark by the National Park Service in 1969 and a Natural and Scientific Area by the state of Kansas in 1987.



There are three administration buildings on the Baker campus. Collins House is across from the Collins Library. It was given to the university by the Collins-Dietrich family. Collins House is the home of the Baker President and has been since 1950. It hosts many University social gatherings.

Constant Hall, the administration headquarters, was built in 1964. The President, Academic Administration, University Advancement, and the Business Office are located in Constant Hall. It also contains the Computer Center, the mailroom and the Personnel Services.

Baker also has tennis courts, intramural fields, a green house, the Old Castle Museum complex, the Flemming Pavilion, and Hartley Plaza.

Baker accomodates three dormitories. They are Gessner Hall, Irwin Hall, and Denious Hall. Baker also has four fraternities and four sororities residing near the campus. They are Sigma Phi Epsilon, Kappa Sigma, Delta Tau Delta, Zeta Chi, Zeta Tau Alpha, Phi Mu, Delta Delta Delta, and Alpha Chi Omega.



Baker's school of business/economics was formally introduced in the year 1926. Dr. Harold Guest, a Stanford University graduate was chair of the department at it's founding. He continued his teaching at Baker until his death, except for a period during World War II in which he worked for the federal government.

Centenary Hall was erected in the year 1884, and housed the business/economics department until 1964 when the hall was torn down due to structural weaknesses. At that time the current administration building (Constant Hall) was built, with the business/economics department moved to the first floor. The department moved to its current home in Mabee Hall in December of 1990 after reconstructive work was done.

Prior to the founding of a formal department of business/economics in the 1920's, general courses had been offered in the field of commerce since Baker's founding in 1858, and even earlier before its charter was established. At its inception the business/economics department's primary focus was on the study of economics. Other business/economics's programs have developed over the years with the latest being the accounting classes which were first seen at Baker in 1980.

During the 1950's a group of business majors formed an association called the Business Roundtable that held monthly meetings to discuss current trends in the business world. Some enthusiasm was established, but did eventually die out.

The Baker University Department of Business/Economics enrolls approximately 40% of all students on campus. The department's faculty consists of 7 professors teaching courses in accounting, business law, economics, finance, management, fashion merchandising, and international business. The Department is chaired by Dr. Stuart Dorsey.

## ***COLONY HISTORY***

In February of the year 1991, Dr. Stuart Dorsey introduced the idea of a business organization on the Baker University campus. After several discussions in Dr. Dorsey's classes, an informal meeting was arranged for interested members.

- Current V.P. for Activities, Jeff Gabriel, contacted several organizations regarding membership information.
- Dr. Stuart Dorsey, a Deltasig alumnus, spoke with Dean Ferguson, Director of Chapter Services, to obtain information on the possibility of a Delta Sigma Pi chapter at Baker. Mr. Ferguson was hesitant about the size of the university at first, but after learning of the other organization's currently established, and the fact that Baker is a residential campus, he became quickly enthusiastic.
- The number of interested students grew, and when given the choice of a club or a fraternity, it became evident that the students preferred the benefits of fraternity membership.
- Throughout the months of March and April, several meetings were held to spark interest and discuss the opportunities open to the group. During one such meeting in early April, members of the Iota Chapter at the University of Kansas shared their experiences as Delta Sigma Pi members.
- After the meeting with Iota members, it was established those interested that Delta Sigma Pi was the fraternity of choice.
- An executive board was elected late in the month of April, and Dr. Stuart Dorsey was appointed as our advisor.
- In early May the group was invited to the 38th Annual Grand Chapter Congress, in Washington, D.C. Karen Bess, President, and Karen Dick, Senior Vice President, attended the early days of the congress (August 11-14).
- The petition for colony status was drawn up and signed by the interested business majors and supportive faculty members at a barbecue on May 9, 1991. Thereafter, the petition was mailed to The Central Office on May 16th.
- Throughout the endeavor to gain colony status, and eventually chapter status, the faculty and administration, especially Mr. David Pittman, University Treasurer, and Dr. Dan Lambert, University President, helped through financial assistance and enthusiastic support.

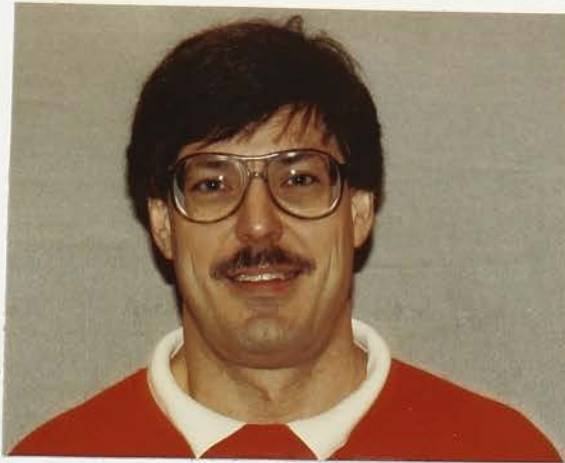
- In mid-July of 1991, notification arrived that the petitioning group of Baker University had been granted colony status by the International Fraternity of Delta Sigma Pi; the group officially became known as Beta Upsilon Colony.
- Contact was kept throughout the summer to keep the colony members well informed.
- The first meeting of the 1991-1992 school year was held September 5th, preceded by an executive meeting on September 3, 1991. The executives discussed recruiting and programming. Dr. Dorsey emphasized the devotion of the executives and the need for new membership.
- At the second meeting, on September 17, 1991, the colony met the district director, Brad Wirths, who expressed enthusiasm about the colony's progress.
- Thanks to the close-knit atmosphere of Baker University, the main recruitment tool was the "Baker Grapevine." With a relatively small enrollment, it is easy to gain enthusiasm by word of mouth.
- Dean Ferguson visited the colony on October 1, 1991. Throughout the day he met with each executive, discussing his/her role. That night, the executives and Dean Ferguson met for dinner, and later he spoke to the entire colony at a bi-monthly meeting.
- Fund-raising activities in October included selling sidewalks for decoration during Homecoming Week and sponsoring a piethrowing booth during the city's annual Mapleleaf Festival (Oct. 19).
- On November 12, 1991 Beta Upsilon Colony co-sponsored a Red Cross Blood Drive.
- In addition to the first professional speaker (Dean Ferguson) on October first, the colony sponsored a speech by Jim Ferrell, President of Ferrell Gas, on December 4, 1991.
- Arriving back on campus in early January of 1992, the executive's first meeting focused on the petition completion deadline.

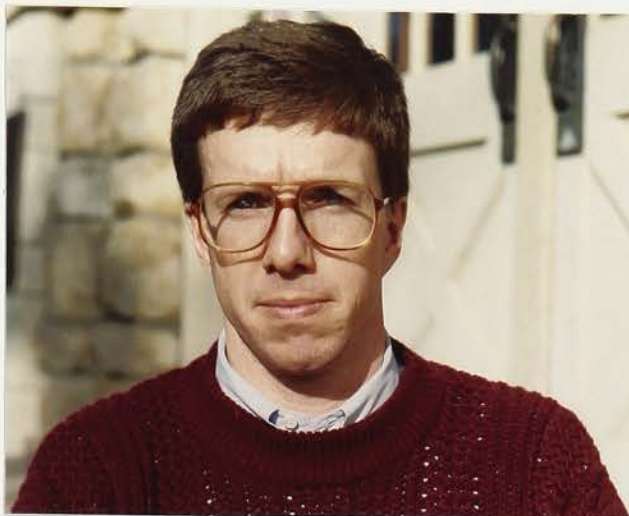
**Mr. Lee E. Green/Alumnus**
